A BILL

To amend the Homeland Security Act of 2002 to provide for active shooter and mass casualty incident response assistance, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Active Shooter Pre-
5 paredness Enhancement Act of 2016”.

6 **SEC. 2. ACTIVE SHOOTER AND MASS CASUALTY INCIDENT**

7 **RESPONSE ASSISTANCE.**

8 (a) IN GENERAL.—Subtitle H of title VIII of the
9 Homeland Security Act of 2002 (6 U.S.C. 451 et seq.)
10 is amended by adding at the end the following:

1 **“SEC. 890B. ACTIVE SHOOTER AND MASS CASUALTY INCI-**
2 **DENT RESPONSE ASSISTANCE.**

3 “(a) **IN GENERAL.**—The Secretary, in consultation
4 with the Attorney General and the heads of other Federal
5 agencies as appropriate, shall develop and make available
6 to State, local, tribal, territorial, private sector, and non-
7 governmental partners guidance to assist in the develop-
8 ment of emergency action and response plans for active
9 shooter and mass casualty incidents in public and private
10 locations, including facilities that have been identified by
11 the Department as potentially vulnerable targets.

12 “(b) **GUIDANCE.**—Guidance developed and made
13 available under subsection (a) may relate to the develop-
14 ment of the following:

15 “(1) A strategy for properly responding to an
16 active shooter or mass casualty incident in a public
17 or private location, including evacuating and pro-
18 viding care to persons in the location, with consider-
19 ation given to the needs of persons with disabilities.

20 “(2) A plan for establishing a unified command,
21 including identification of staging areas for law en-
22 forcement, fire response, and medical personnel.

23 “(3) A schedule for regular testing of equip-
24 ment used to receive communications during an ac-
25 tive shooter or mass casualty incident.

1 “(4) A practiced method and plan to commu-
2 nicate with occupants of a public or private location
3 during an active shooter or mass casualty incident.

4 “(5) A practiced method and plan to commu-
5 nicate with the surrounding community regarding an
6 active shooter or mass casualty incident and the
7 needs of Federal, State, and local officials.

8 “(6) A plan for coordinating with volunteer or-
9 ganizations to expedite assistance for victims.

10 “(7) A schedule for joint exercises and training.

11 “(8) A plan for outreach to facilities that have
12 been identified by the Department as potentially vul-
13 nerable targets.

14 “(9) Other planning documents, as determined
15 by the Secretary, including appropriate regionally-fo-
16 cused products, plans, training, and outreach.”.

17 (b) TECHNICAL AND CONFORMING AMENDMENT.—
18 The table of contents in section 1(b) of the Homeland Se-
19 curity Act of 2002 (Public Law 107–296; 116 Stat. 2135)
20 is amended by inserting after the item relating to section
21 890A the following:

 “Sec. 890B. Active shooter and mass casualty incident response assistance.”.

22 **SEC. 3. LAW ENFORCEMENT TRAINING FOR MASS CAS-**
23 **UALTY AND ACTIVE SHOOTER INCIDENTS.**

24 Section 2006(a)(2) of the Homeland Security Act of
25 2002 (6 U.S.C. 607(a)(2)) is amended—

1 (1) by redesignating subparagraphs (E)
2 through (I) as subparagraphs (F) through (J), re-
3 spectively; and

4 (2) by inserting after subparagraph (D) the fol-
5 lowing:

6 “(E) training exercises to enhance pre-
7 paredness for and response to mass casualty
8 and active shooter incidents and security events
9 at public and private locations;”.

10 **SEC. 4. CONSIDERATION OF ACTIVE SHOOTER THREATS.**

11 Section 2007(b) of the Homeland Security Act of
12 2002 (6 U.S.C. 608(b)) is amended—

13 (1) by redesignating paragraph (9) as para-
14 graph (10); and

15 (2) by inserting after paragraph (8) the fol-
16 lowing:

17 “(9) Active shooters.”.
