Dear President Trump:

We write to urge you to take swift action to nominate qualified individuals to the Governor vacancies on the U.S. Postal Service Board of Governors. While we appreciate the recent nomination of three individuals, and look forward to considering their nominations swiftly, the Board still lacks a quorum of four Governors even if these individuals are confirmed. Without a quorum, the Postal Service cannot make key operational decisions or provide accountability for operational deficiencies, such as intentional mail delays, drug trafficking through the Postal Service's network, and dramatically falling mail volumes and revenue.

Established in 1970, the Board is composed of eleven positions—nine Governors, and the Postmaster General and the Deputy Postmaster General, who are appointed by the Board. The Postal Service considers the Board "comparable to a board of directors of a publicly held corporation," providing enterprise-wide operational and financial accountability. The Board has the sole authority to appoint, remove and determine the salary and term of the Postmaster General.

According to federal law, Governors should be chosen based on their experience in public service, law or accounting, or on their demonstrated ability to manage large organizations or corporations.⁴ Further, at least four of the nine Governors should have experience leading a large private or public organization that employs at least 50,000 employees.⁵

The Board has not had a quorum to meet since December 2014, ⁶ and has not had any Governors since December 8, 2016. ⁷ The absence of any Governors prevents the Postal Service

from selecting a certified public accounting firm to certify the accuracy of its financial statements, filing a request with the Postal Regulatory Commission for adjustment of postal rates on an expedited basis, changing the lists of market dominant and competitive products, establishing of rates and classes of competitive products, and removing or appointing a Postmaster General and Postal Service Inspector General. Without new nominees, an incomplete Board will continue to present operational and financial risks to the Postal Service.

The Postal Service is facing significant operational and financial challenges that require attention and action by a Board of Governors. According to the USPS Office of Inspector General (OIG), the Postal Service has failed to address recommendations from 97 audit reports, with a potential monetary impact of \$1.8 billion. The USPS OIG has also highlighted misreported mail delays, and employee trafficking of illicit drugs. Postal Service shortcomings are likely to disproportionally affect rural Americans who are more reliant on post offices. Financially, the Postal Service lost \$1.3 billion and experienced a 4.1 percent loss in First-Class mail—the most profitable class of mail—in the first half of 2017.

Without a Board, Postal Service management has stopped pursuing operational changes to match falling volumes, ¹³ instead opting to default on payments for Postal Service employee benefits to stockpile cash. ¹⁴ On September 27, 2017, after months of warnings, Postmaster General Megan Brennan informed the Office of Personnel Management that the Postal Service would not make payments for retiree benefits totaling \$6.9 billion. ¹⁵

We encourage your prioritized nomination of at least one more qualified individual, in addition to the individuals that were just nominated to fill the vacancies of the Postal Service Board of Governors. As the only Senate-confirmed leaders of the Postal Service, Governors are vital to holding Postal Service management accountable for decisions that affect Postal Service customers, employees, and the American taxpayers. We need a fully functioning Board to
