14	unique businesses that primarily provide cloud
15	computing services or products, including at
16	least 2 representatives from a small business

18	Business Act (15 U.S.C. 632(a))).
19	"(G) At least 2 other representatives of the
20	Federal Government as the Administrator de-
21	termines necessary to provide sufficient balance,
22	insights, or expertise to the Committee.

24	member of the Committee shall be appointed not

App.) shall not apply to the 23 Committee. 24 "(f) Detail of Employees.—Any Federal Government employee may be detailed to the Committee without

- 1 reimbursement from the Committee, and such detailee
- 2 shall retain the rights, status, and privileges of his or her
- 3 regular employment without interruption.
- 4 "(g) Postal Services.—The Committee may use
- 5 the United States mails in the same manner and under
- 6 the same conditions as agencies.

- 8 "(1) Interim reports.—The Committee may
- 9 submit to the Administrator and Congress interim
- 10 reports containing such findings, conclusions, and
- 11 recommendations as have been agreed to by the
