Ltd or any other transactions related to business in Romania, China, Russia, Kazakhstan, Ukraine, Czech Republic, or any other countries. As part of this production, please also include all of your communications regarding these transactions with Hunter Biden, Joe Biden, James Biden, James Gilliar, Rob Walker, Ye Jianming, Chi Ping Patrick Ho, Zang Jian Jun, Gongwen Dong, Mervyn Yan, Gabriel Popoviciu, or any other associates.
