Dear Mr. Newport:

The Committee on Homeland Security and Governmental Affairs is continuing to conduct oversight of the Trump Administration's trade policies, specifically relating to the tariffs on steel and aluminum. We respectfully write to request information about your company's role in the tariff exclusion process.<sup>1</sup>

On March 8, 2018, the Trump Administration announced tariffs on steel and aluminum, authorized by Section 232 of the 1962 Trade Expansion Act.<sup>2</sup> On March 18, 2018, the Commerce Department established a process for businesses to apply for exclusions of specific steel and aluminum import products.<sup>3</sup> Upon receiving an exclusion request, the Department determines whether the product is produced domestically in sufficient availability and quality.<sup>4</sup> The Department also established a process through which other businesses or organizations could object to exclusion requests by providing information on the domestic production of the product that is the subject of the exclusion request.<sup>5</sup>

Commerce Secretary Wilbur Ross stated that the Department had received more than 20,000 steel and aluminum exclusion requests. By the end of July 2018, the Department had reportedly denied 639 requests, with half of those denials reportedly receiving an objection from U.S. Steel, Nucor, or AK Steel Holding Corporation. Department officials allegedly boasted that "they have not granted a single steel exclusion request that drew an objection" from domestic steel producers.

U.S. businesses have reported that the exclusion process is time-consuming and burdensome.<sup>9</sup> Business leaders have described the exclusion process as "miserable" and expressed concerns about its arbitrary and uncertain nature.<sup>10</sup>

In light of the concerns about the exclusion process for the steel and aluminum tariffs, we respectfully request the following information:

- 1. Please provide a list of all objections that the AK Steel Holding Corporation has submitted to the Department since March 2018, including the following data:
  - a. The date on which your company filed the objection(s);
  - b. Whether the Department requested any additional information or clarification about your company's objection(s), and the date(s) of those request(s) and any response to those request(s); and
  - c. Whether the Department approved or denied the exclusion(s) to which your company filed objection(s), and the date(s) of the Department's final decision(s).
- 2. Please explain how the AK Steel Holding Corporation determines whether to submit an objection to a particular exclusion request.
- 3. Please produce all documents and communications between or among employees or agents of the AK Steel Holding Corporation and employees or contractors of the Commerce Department for the period September 1, 2017 to the present referring or relating to the steel and aluminum tariffs, the tariff exclusion process, or objections to tariff exclusions.

Please produce all documents and communications between or among employees or agents of the AK Steel Holding Corporation and employees of the Executive Office of the President for the period September 1, 2017 to the present referring or relating to the steel and aluminum tariffs, the tariff exclusion process, or objections to tariff exclusions.

Please provide this information as soon as possible but no later than 5:00 p.m. on September 10, 2018.

The Committee on Homeland Security and Governmental Affairs is authorized by Rule XXV of the Standing Rules of the Senate to investigate "the efficiency, economy, and effectiveness of all agencies and departments of the Government." Additionally, S. Res. 62 (115th Congress) authorizes the Committee to examine "the efficiency and economy of all branches of the Government including the possible existence of fraud, misfeasance, malfeasance, collusion, mismanagement, incompetence, corruption, or unethical practices . . . ." 12
