Dear Chairman Paul,

We call on you, as Chairman of the Homeland Security and Governmental Affairs Committee (HSGAC), to immediately hold a hearing on the Trump Administration's escalatory deployment of 4,000 federalized National Guardsmen and 700 active-duty Marines to Los Angeles, California against the objections of California's Governor and express warnings of state and local law enforcement officials. These actions make our communities less safe, threaten to undermine state governments' rights throughout the United States and politicize the role of the military in our nation.<sup>1</sup>

Maintaining public safety is the job of local law enforcement. We strongly condemn violence and support the right to peaceful protest. Local law enforcement have been dealing with these protests and both elected officials and law enforcement leaders on the ground have cautioned that sending federal service members is unhelpful.<sup>2</sup> Governor Newsom, the commander in chief of the California National Guard, has specifically called for the President to defederalize the Guard and remove these service members.<sup>3</sup>

Nevertheless, the President has harmed public safety by federalizing a state's National Guard against the wishes of the governor and sending them into a city whose law enforcement is

already dealing with the protests. President Trump has now ordered active-duty Marines to deploy to a city within our own country, a further meritless and dangerous escalation. There are reports that Homeland Security Secretary Kristi Noem has requested Defense Secretary Pete Hegseth to direct service members to detain and arrest lawbreakers, provide munitions, and begin preparing active-duty service members to "aid in developing SOPs (standard operating procedures) and TTPs (tactics, techniques and procedures)" for future situations.<sup>4</sup>

The U.S. military has been barred from serving as law enforcement in the United States since after Reconstruction.<sup>5</sup> While the service members that the President has deployed are not yet officially carrying out law enforcement responsibilities, having them protect federal buildings and missions and putting them on the ground could lead to unintentional engagements that further escalate the situation and may ultimately lead the President to violate Posse Comitatus or use the events as a pretext to invoke the Insurrection Act. This is counter to every tenet of a free society.

The Homeland Security and Governmental Affairs Committee is the U.S. Senate's chief oversight committee and has a strong tradition under Republican and Democratic leadership of holding the Executive Branch accountable to the law and to the American people. This is all the more important given the recent use of force and handcuffing of a Senator seeking answers for his constituents. We therefore call on you to immediately hold an oversight hearing with Administration officials, including Secretary of Homeland Security Kristi Noem and Secretary of Defense Pete Hegseth, to provide answers regarding the administration's dangerous and intentionally provocative actions.
