Dear Secretary Noem:

On January 20, 2025, Acting Secretary Benjamine C. Huffman terminated all current memberships on advisory committees within DHS. This move, however, will undoubtedly negatively impact DHS's strategic priorities, interrupt important national security work, and delay activities required under law. I recognize that every President has the right to their own advisors, however, the immediate termination without well-qualified replacements ready to step in was brash and shortsighted. I urge you to immediately reinstate members of advisory committees or expeditiously appoint qualified individuals to enable their mandated work to continue uninterrupted and prevent significant delays.

DHS's advisory committees are an important resource for the Department and in many cases, these committees are mandated by law. For example, the Bipartisan Safer Communities Act of 2022 mandated the creation of the Federal School Safety Clearinghouse External Advisory Board. This Board was created to support the Department's school safety work and provide expertise to the Federal School Safety Clearinghouse created by President Trump. Another example, critical to my home state of Michigan, is the Great Lakes Pilotage Advisory Committee (GLPAC) that is required by the Great Lakes Pilotage Act to work with the U.S. Coast Guard on safe navigation practices in the Great Lakes. Congress created and required these committees, amongst others, for a reason. Almost all of these advisory committees have membership qualification requirements and require a fair balance in points of views represented.

Other advisory committees perform important national security work. For example, the Cyber Safety Review Board, or CSRB, as established in Executive Order 14028, Improving the *Nation's Cybersecurity*, plays a significant role in analyzing cyber incidents and providing actionable recommendations to prevent future cyber incidents. The CSRB is comprised of both government and non-government members to bring top cybersecurity minds together. The actions to remove members from the CSRB has significantly impacted the Board's important investigation into the ongoing Salt Typhoon telecommunications hack. In accordance with the CSRB's charter, members should be well-qualified and respected experts and appointed without regard to political affiliation.

Outside of cybersecurity investigations, other advisory committees performing important national security work include the Homeland Security Advisory Council, the Aviation Security Advisory Committee, and the President's National Security Telecommunications Advisory Committee, to name a few. Members of these committees conduct research and provide critical recommendations to improve the Department's ability to combat online child exploitation and abuse, protect our borders, provide baseline security standards for cloud service providers, prepare our nation for post-quantum cryptography, and secure our airports, airlines, and

transportation passengers across the nation. These important activities, amongst others, ensure the Department and its components are effective and efficient in their national security missions to face both cyber and physical threats to our homeland.

The wholesale removal of members of the Department's advisory committees only serves to benefit our foreign adversaries, like China, Russia, and Iran. Prior to your confirmation, you and I discussed the priority of combating foreign adversaries, securing our borders, and protecting our nation from cyberattacks, amongst other priorities. You pledged to me that you would work with me in a bipartisan, fact-based manner to counter threats to our homeland. Disbanding members of all advisory committees is counter to our common goal to protect our nation. Now that you are confirmed as Secretary, I urge you to quickly reinstate members of advisory committees or appoint qualified individuals in accordance with established charters and existing law.

It is critical that DHS continues to be at the front of protecting Americans, all Americans, from security and public safety threats. The Department's work should remain non-partisan, transparent, and responsive to congressional oversight and the American people.

I appreciate your attention to this important matter and for your convenience, I have included a list of some active advisory committees and their establishment authority. I look forward to working with you and the Department.
