

CHAIRMAN PAUL FLASH REPORT

THE WEAPONIZATION OF FEDERAL WATCH LISTS

Today, Chairman Paul is releasing additional findings from his [ongoing investigation](#) into weaponized watchlisting by the federal government through documents obtained by the Federal Bureau of Investigation about Christine Crowder. During a U.S. Senate Committee on Homeland Security and Governmental Affairs [hearing](#) on September 30, 2025, Senior Federal Air Marshal Mark Crowder testified that his wife, Christine, a Catholic school teacher, was placed on a terrorist watch list and had been surveilled by the Federal Bureau of Investigation (FBI) and the Federal Air Marshal Service for over two years.

Key Findings:

- 1. THE FBI OPENED THE INVESTIGATION INTO CROWDER BASED ON A TIP FROM A FORMER FRIEND. INITIAL FINDINGS INDICATED NEGATIVE GEOLOCATION, FACIAL RECOGNITION, AND CRIMINAL HISTORY OR EXTREMIST ACTIVITY.**
- 2. THOUGH THE FBI ACKNOWLEDGED A NEED TO INTERVIEW CROWDER, THEY CLAIMED SHE ILLEGALLY ENTERED THE U.S. CAPITOL AND RECOMMENDED HER FOR WATCHLISTING AND EXPANDED SELECTEE STATUS.**
- 3. THE FBI PHYSICALLY SURVEILLED CROWDER'S HOUSE AT LEAST FOUR TIMES FOR THE PURPOSE OF IDENTIFYING HER AND HER PROPERTY.**
- 4. THE U.S. ATTORNEY'S OFFICE ACCEPTED THE CASE FOR PROSECUTION SOLELY BASED ON THE TIP WITHOUT FULLY VERIFYING HER IDENTITY AND THEN RECOMMENDED THE FBI CONDUCT A SOCIAL MEDIA ANALYSIS.**
- 5. NEARLY TWO YEARS INTO THE INVESTIGATION AND OVER A MONTH AFTER A PHOTO FROM A CONFIDENTIAL HUMAN SOURCE CONFIRMED THE CASE OF MISTAKEN IDENTITY [see below], THE FBI INVESTIGATION WAS CLOSED.**

TIMELINE OF FBI INVESTIGATION INTO CHRISTINE CROWDER

DETAILING A 23-MONTH INVESTIGATION BASED ON AN ANONYMOUS TIP ABOUT AN AIR MARSHAL'S WIFE ACCUSED OF BEING AT THE U.S. CAPITOL ON JANUARY 6 WHICH ENDED IN A CASE OF MISTAKEN IDENTITY.

An Anonymous Tip

January 11, 2021: The FBI received an anonymous tip stating the tipster was a "former friend" who recognized Christine Crowder from news coverage of January 6.

A "Verified" Known or Suspected Terrorist

July 2, 2021: The FBI conducted physical surveillance of the Crowder household.
July 14, 2021: The FBI approved the paperwork to add Crowder to the Terrorist Screening Dataset, labeling her a domestic terrorist.

Future Search Warrants

February 13, 2022: The FBI conducted physical surveillance of Crowder's home for the purpose of photographing the property for future search warrants.
February 23, 2022: FBI receives a video from the anonymous tipster of an individual they believe is Crowder exiting the U.S. Capitol.

1.5 Years Later Anonymous Tipster Interviewed

May 24, 2022: The anonymous tipster who reported Crowder is interviewed by the FBI. In the interview, the tipster and their spouse tell the FBI they saw videos Crowder posted to Facebook from inside the Capitol.

Facebook Search (Warrant)

October 27, 2022: The FBI executed a search warrant on Crowder's Facebook account via Facebook's Law Enforcement Portal.

In Light of "New" Evidence

June 6, 2023: The FBI closes the investigation of Crowder. In the memo, the FBI states the reasons for closing the investigation as negative results of a geofence query and facial recognition, Crowder's ride share receipt, and the photograph of her wearing clothes that were not consistent with the original tip.

Full Investigation

June 25, 2021: The FBI files the paperwork to open a full investigation into Christine Crowder. In this paperwork, the FBI recommends Crowder be watchlisted despite a negative search for her geolocation or facial recognition at the U.S. Capitol on January 6, 2021.

Watchlisting Travel Notification

August 2, 2021: The FBI agent assigned to the Crowder case filed a July 15, 2021, notification from the Terrorist Screening Observation Unit of planned travel by Crowder. The document states she was watchlisted by the FBI and should receive Expanded Selectee status by TSA.

3rd Time's the Charm: Attempt to Identify

April 26, 2022: The FBI conducted physical surveillance of Crowder's home in order to identify her.
April 13-22, and April 29, 2022: The FBI reviewed U.S. Capitol Police CCTV footage for the purpose of identifying Crowder in the U.S. Capitol on January 6.

Prosecution Without Identification

July 7, 2022: The U.S. Attorney's Office tells the FBI Crowder's case will be accepted for prosecution despite the FBI being unable to positively identify her through physical surveillance.
July 20, 2022: The FBI conducted physical surveillance of Crowder's home in order to identify her.

Crowder Finally Identified and Interviewed

May 2, 2023: Crowder was interviewed by FBI agents. She showed the agents the outfit she wore on that day and a ride share receipt showing a ride occurring at the time she was accused of being in the U.S. Capitol.
May 4, 2023: A confidential human source provided the FBI with a photo showing Crowder's attire on January 6.

Details:

(U) Captioned investigation is being initiated based on photographic and/or video evidence that Christine J. CROWDER unlawfully entered the United States Capitol Building, a Restricted Building, on 6 January 2021, in violation of federal laws to include violations of 18 U.S.C. section 1752 and 40 U.S.C. section 5104.

(U) CDC APPROVAL

(U) Field Office CDC has reviewed the underlying predication and concurred with the opening of this full investigation. Pursuant to CTPG, section 10.4.1, the investigation will be reviewed by the CDC at least semi-annually.

(U) SUMMARY OF PREDICATION:

(U) The U.S. Capitol, which is located at First Street, SE, in Washington, D.C., is secured 24 hours a day by U.S. Capitol Police. Restrictions around the U.S. Capitol include permanent and temporary security barriers and posts manned by U.S. Capitol Police. Only authorized people, such as members of the United States Congress and their professional staff, with appropriate identification are allowed access inside the U.S. Capitol.

(U) On January 6, 2021, the exterior plaza of the U.S. Capitol was closed to members of the public.

(U) On January 6, 2021, a joint session of the United States Congress convened at the United States Capitol. During the joint session, elected members of the United States House of Representatives and the United States Senate met in separate chambers of the United States Capitol to certify the vote count of the Electoral College of the 2020 Presidential Election, which had occurred on November 3, 2020. The joint session began

at approximately 1:00 p.m. (Eastern Standard Time). The Vice President of the United States - Mike Pence - was present and presiding in the Senate chamber.

(U) With the joint session underway and with Vice President Mike Pence presiding, a large crowd gathered outside the U.S. Capitol. As noted above, temporary and permanent barricades were in place around the exterior of the U.S. Capitol building, and U.S. Capitol Police were present and attempting to keep the crowd away from the Capitol building and the proceedings underway inside.

(U) At approximately 2:00 p.m., certain individuals in the crowd forced their way through, up, and over the barricades and officers of the U.S. Capitol Police, and the crowd advanced to the exterior façade of the U.S. Capitol. At such time, the joint session was still underway and the exterior doors and windows of the U.S. Capitol were locked or otherwise secured. Members of the U.S. Capitol Police attempted to maintain order and keep the crowd from entering the Capitol; however, shortly after 2:00 p.m., individuals in the crowd forced entry into the U.S. Capitol, by, among other things, breaking windows.

(U) Shortly thereafter, at approximately 2:20 p.m. members of the United States House of Representatives and United States Senate, including the President of the Senate, Vice President Mike Pence, were instructed to-and did-evacuate the chambers. Accordingly, the joint session of the United States Congress was effectively suspended until shortly after 8:00 p.m. Vice President Pence remained in the United States Capitol in a secure location from the time he was evacuated from the Senate Chamber until the sessions resumed.

(U) During national news coverage of the aforementioned events, video footage which appeared to be captured on mobile devices of persons present on the scene depicted evidence of scores of individuals inside

the U.S. Capitol building without authority to be there and engaging in conduct in violation of Federal laws.

(U) Social media and video footage of the event show rioters making statements consistent with Anti-Authority/Anti-Government (AA/AG) Extremism. A review of open source and social media posts leading up to and during the event indicate that individuals participating in the "Stop the Steal" rally were angered about the results of the 2020 Presidential election, and felt that Joseph Biden had unlawfully been declared President-Elect. Users in multiple online groups and platforms discussed traveling to the Capitol armed or making plans to start a "revolution" on that day. Participants in the riot used violence, which resulted in injuries to multiple law enforcement officers and damage to the United States Capitol building, all with the intent to subvert the certification of the electoral election ballots and thereby disrupt the election of the President of the United States in furtherance of their AA/AG ideology.

(U) CROWDER was identified by a tipster using the <http://www.fbi.gov/USCapitol> online portal.

Tipster provided the following, "We were aware of one of our former friends who was supposedly onsite during the Capitol invasion. I recently reviewed a video

- The writer reviewed the video listed above from the ABC13 Houston Facebook page. The writer observed a white female that resembles other photos of the captioned subject exit what appears to be the Capitol Building with the phrase "MURDER THE MEDIA" apparently carved in the door. The subject can be observed exiting the building past what appears to be Capitol Policeman holding the door open for several people as they exit. Subject is wearing a red ball cap that reads "Keep America Great"; dark, narrow rimmed glasses; long brown hair; a long brown puffy jacket; blue back pack over right shoulder with what appears to be a "The North Face" brand tag on the shoulder strap.
- An open source search of Christine Crowder revealed a FaceBook page for 'Christine Crowder (Christine Leonardo)' which matches the results of other open source search for the captioned subject.
- In the photo section of the Christine Crowder FaceBook page the writer found photos of a white female resembling the female seen exiting the Capitol Building in the aforementioned video. The photos depict a white female with brown hair, red ball cap reading "Keep America Great," and dark, narrow rimmed glasses.
- An open source search of Christine Crowder revealed a LinkedIn account by the same name, with a profile picture resembling the aforementioned video on Facebook, as well as a Facebook page associated with Christine Crowder. The profile picture depicts a white female with long brown hair and dark, narrow framed glasses.
- An open source search of Christine Crowder revealed an Instagram account with user name [REDACTED] associated with a Christine Crowder. Another open source search associated the subject with the email address [REDACTED].
- Houston Airport Liaison Agents searched the ARC database revealing CROWDER traveled from Houston to Washington D.C. on 1/4/2021 aboard United Airlines flight 6096 and returned 1/7/2021 aboard United Airlines flight 6020.
- Subject lists current employment as a [REDACTED] at St. Edward School on her LinkedIn account. Open source searches of [REDACTED] School in the Houston area revealed the [REDACTED] Catholic School in [REDACTED], TX, which is in close proximity to CROWDER's residence in [REDACTED] TX. An online search of the faculty list on the website revealed no results.
- The captioned subject does not appear to conform to any particular ideology or extremist group.
- No prior military employment revealed at this time.
- CROWDER will be interviewed as video shows a person closely matching

her description clearly exiting the Capitol Building.

(U) POTENTIAL VIOLATIONS OF FEDERAL LAW:

(U) Potential violations of federal criminal statutes include:

- Title 18 U.S.C. 231 Civil Disorder
- Title 18 U.S.C. 1752(a) Unlawful Entry - Restricted Building or Grounds
- Title 18 U.S.C. 2101 - Riots
- Title 40 U.S.C. 5104 - Injuries to Property, weapons, and violent entry/disorderly conduct on Capitol grounds

(U) It is therefore requested that a 2660 case be opened and assigned to Special Agent [REDACTED]

(U) PERTINENT SENSITIVE INVESTIGATIVE MATTERS:

(U) There are no known sensitive investigative matters."

(U) WATCHLIST STATUS:

(U) CROWDER participated in the illegal entry into the United States Capitol, with the intent of interrupting the congressional proceeding. These actions resulted in the death of a Federal law enforcement officer, injuries of multiple officers, and damage to the United States Capitol. Based on CROWDER's involvement in these activities, FBI Houston recommends CROWDER for watchlisting and selectee status.

Summary: Christine Janet Crowder entered the U.S. Capitol building during the January 6, 2021 siege.

Evidence:

On 01/11/2021, [REDACTED] and husband [REDACTED] sent a tip to www.fbi.gov/USCapitol identifying Christine Crowder as someone who exited the U.S. Capitol building on 01/06/2021. In the tip, [REDACTED] and [REDACTED] indicated they were former friends of Crowder and saw her on a local news station's video of her exiting the Capitol building on 01/06/2021. [REDACTED] and [REDACTED] viewed Crowder's Facebook page, which showed Crowder with the same hat and glasses.

In an interview with [REDACTED] and [REDACTED] both provided additional information regarding the tip information they provided to the FBI. [REDACTED] stated that following the siege on U.S. Capitol on 01/06/2021, she and her husband saw a video on ABC News that showed Crowder exiting the building with others. After recognizing Crowder, [REDACTED] and [REDACTED] viewed Crowder's Facebook account, where they saw videos posted by Crowder regarding her trip to Washington D.C. on 01/06/2021. According to [REDACTED] one video showed Crowder on the plane heading to D.C., and another showed Crowder on the grounds at the rally for former President Trump. [REDACTED] described the videos as "livestreamed" footage of Crowder's trip. [REDACTED] stated that she believed the videos were deleted based on a gap in Crowder's postings on her Facebook page from 01/01/2021 to 01/07/2021. [REDACTED] stated that she was one-hundred percent sure that Christine Crowder was the person on the ABC News video walking out of the U.S. Capitol. Below is a screen shot of the video that was provided by [REDACTED] and [REDACTED]



FOOTAGE SHOWS A LINE OF TRUMP SUPPORTERS EXITING THE CAPITOL BUILDING AS RIOTS WERE DISPERSED.

After receiving the tip information, Special Agent [REDACTED] reviewed the video listed above from the ABC13 Houston Facebook page. Special Agent [REDACTED] observed a white female that resembled other photos of the captioned subject exiting what appears to be the Capitol Building with the phrase "MURDER THE MEDIA" apparently carved in the door. The subject can be observed exiting the building past what appears to be Capitol Police Officer holding the door open for several people as they exited. The subject was wearing a red ball cap that read "Keep America Great"; dark, narrow rimmed glasses; long brown hair; a long brown puffy jacket; blue backpack over the right shoulder with what appears to be a "The North Face" brand tag on the shoulder strap.

An open source search of Christine Crowder revealed a Facebook page, [www.facebook.com/\[REDACTED\]](http://www.facebook.com/[REDACTED]), for Christine Crowder (Christine Leonardo), which matches the results of other open source search for the captioned subject.

In the photo section of the Christine Crowder Facebook page, Special Agent [REDACTED] found photos of a white female resembling the female seen exiting the Capitol Building in the aforementioned video. The photos depicted a white female with brown hair, red ball cap reading "Keep America Great," and dark, narrow rimmed glasses.

An open source search of Christine Crowder revealed a LinkedIn account by the same name, with a profile picture resembling the aforementioned video on Facebook, as well as a

Facebook page associated with Christine Crowder. The profile picture depicted a white female with long brown hair and dark, narrow framed glasses.

On 04/07/2021, Houston Airport Liaison Agents searched the ARC database, which revealed Cro traveled from Houston to Washington D.C. on 1/4/2021 aboard United Airlines flight 6096 and returned 1/7/2021 aboard United Airlines flight 6020.

As part of this investigation, I reviewed several hours of security footage and located a video of CROWDER walking throughout the Capitol and exiting the building. I first located Crowder on security camera 0178 USCH 01 Crypt East, walking through the Crypt located on the first floor of the Capitol building. She can be seen entering camera view at 20:30:28 according to camera footage.







She walks in front of the statue of Winston Churchill and then through the archway. Crowder then walks down the stairs towards the door and into the next room. Crowder exits camera view.







Christine Crowder (CROWDER), date of birth (DOB) [REDACTED] was interviewed by Special Agents (SA) [REDACTED] and [REDACTED] at her home at [REDACTED]. After being advised of the identity of the interviewing Agent and the nature of the interview, CROWDER provided the following information:

CROWDER flew into Washington DC from Houston on January 4, 2021. CROWDER arranged to attend the rally in DC with two female friends, but CROWDER flew separately from them. CROWDER was unable to reserve a hotel room for three days and therefore reserved a room at a different hotel during CROWDER's last night in DC. CROWDER's friends that she intended to attend the rally with were staying at a different hotel.

On the morning of January 6, CROWDER woke up early and attempted to link up with her friends so that they could travel to the rally together. CROWDER was unsuccessful in reaching her friends and CROWDER assumed that her friends had already departed to attend the rally and left CROWDER alone. CROWDER became emotional at the hotel and was unsure what to do. CROWDER was approached by two females who were sympathetic to CROWDER and asked CROWDER to join them. CROWDER arrived to the rally at around 6 a.m. and waited there until Donald Trump's speech began. CROWDER was frustrated because the speech was supposed to start at 10 a.m. but did not begin until shortly after 11 a.m.

[NOTE: Interviewing Agents asked CROWDER if she had photos of herself taken on January 6. CROWDER provided Agents with a photo that showed CROWDER wearing a 'Trump 45' beanie, a black jacket, a white scarf with black stripes, and brown 'UGG' style boots with white fur on top. CROWDER then retrieved the jacket and scarf from her bedroom and showed them to the interviewing Agents.]

Following the speech, CROWDER again tried to contact her friends in order to link up with them. CROWDER began walking east on Constitution Ave. CROWDER eventually made contact with her friends and they informed her that they were on Independence Ave. CROWDER tried to locate her friends but was again

unsuccessful. CROWDER tried to find a restaurant to eat at, but it was difficult with the amount of people occupying the street and businesses. CROWDER's phone was nearly dead, so CROWDER stepped into a Starbucks coffee shop in order to charge her phone. While CROWDER was charging her phone she began to have a headache and was getting tired. CROWDER thought to go further down the street closer to the Capitol, but ultimately decided to call a Lyft passenger car and return to her hotel where she stayed for the remainder of the evening. The Lyft car dropped CROWDER off nearby the Touchstone Gallery on New York Ave. at approximately 2:30 p.m. From there, CROWDER walked to her hotel.

[NOTE: CROWDER showed interviewing Agents an e-receipt for the Lyft passenger car showing that the ride had been completed at 2:28 p.m.]

On the morning of January 7, CROWDER checked out of her hotel and took a Lyft car to DULLES airport where she boarded a plane bound for Houston.

(U//FOUO) FBI Houston opened a Full Investigation on Christine Janet Crowder based on an anonymous tip provided by a tipster.

(U//FOUO) Tipster provided the following, "We were aware of one of our former friends who was supposedly onsite during the Capitol invasion. I recently reviewed a video

[REDACTED] where is appears that Christine Crowder ([REDACTED] L is existing the Capitol at :25 into the video. On Christines FB profile, there is a link to the event on Jan6th as well as a profile pic showing her with the same hat and glasses. "

(U//FOUO) After conducting pertinent checks to identify selectors associated with Crowder, FBI found no evidence that Crowder definitively entered the Capitol building. Review of video footage both inside and

outside the Capitol did not positively identify Crowder. A geofence query was performed on captioned subject's known cellphone number which returned a negative result for being inside the Capitol grounds.

(U//FOUO) A face search and HUMINT search was performed on the subject which returned a result of possible misidentification of the subject. The HUMINT team did not return any conclusive result that the subject was seen entering the Capitol by any security camera or eye witness.

(U) Writer interviewed Crowder at her home and Crowder provided writer with photos and videos of her activities in Washington D.C. on January 6, 2021. Crowder advised that she was indeed in DC on January 6th, but never stepped on to the Capitol grounds.

(U) Writer was able to identify specific articles of clothing worn by Crowder on January 6th according to the photos that she provided. This clothing was inconsistent with the images provided in the original tip.

(U) Writer was also able to view timestamps of videos and photographs located on Crowder's phone. At the time Crowder was supposedly exiting the Capitol, she was elsewhere in DC. Additionally, writer was able to view an online receipt where Crowder ordered a passenger car service. The route of the passenger car viewable in the receipt is consistent with Crowder's account of her movements in DC on January 6th.

(U) In light of this new evidence, writer recommends closing captioned matter.
