A BILL

To require the Secretary of Homeland Security to establish a national risk management cycle, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "National Risk Manage-

5 ment Act of 2023".

6 SEC. 2. NATIONAL RISK MANAGEMENT CYCLE.

7 (a) IN GENERAL.—Subtitle A of title XXII of the
8 Homeland Security Act of 2002 (6 U.S.C. 651 et seq.)
9 is amended by adding at the end the following:

1 "SEC. 2220F. NATIONAL RISK MANAGEMENT CYCLE. 2 "(a) NATIONAL CRITICAL FUNCTIONS DEFINED.—In 3 this section, the term 'national critical functions' means the functions of government and the private sector so vital 4 5 to the United States that their disruption, corruption, or dysfunction would have a debilitating effect on security, 6 7 national economic security, national public health or safe-8 ty, or any combination thereof. 9 "(b) NATIONAL RISK MANAGEMENT CYCLE.— 10 ((1))RISK **IDENTIFICATION** ASSESS-AND 11 MENT.---"(A) IN GENERAL.—The Secretary, acting 12 13 through the Director, shall establish a recurring 14 process by which to identify and assess risks to 15 critical infrastructure, considering both cyber 16 physical threats and and the associated 17 likelihoods, vulnerabilities, and consequences. 18 "(B) CONSULTATION.—In establishing the 19 process required under subparagraph (A), the 20 Secretary shall consult— 21 "(i) Sector Risk Management Agen-22 cies; 23 "(ii) critical infrastructure owners and 24 operators; 25 "(iii) the Assistant to the President 26 for National Security Affairs;
