## A BILL

To amend the Homeland Security Act of 2002 to direct the Under Secretary for Intelligence and Analysis of the Department of Homeland Security to conduct an annual audit of the information systems and bulk data of the Office of Intelligence and Analysis of the Department, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “DHS Intelligence and  
5 Analysis Oversight and Transparency Act”.

1   **SEC. 2. ANNUAL AUDIT OF DHS OFFICE OF INTELLIGENCE**  
2                   **AND ANALYSIS INFORMATION SYSTEMS AND**  
3                   **BULK DATA.**

4       (a) IN GENERAL.—Subtitle A of title II of the Home-  
5 land Security Act of 2002 (6 U.S.C. 121 et seq.) is amend-  
6 ed by adding at the end the following:

7   **“SEC. 210H. ANNUAL AUDIT OF INFORMATION SYSTEMS**  
8                   **AND BULK DATA.**

9       “(a) DEFINITION.—In this section, the term ‘appro-  
10 priate congressional committees’ means the Committee on  
11 Homeland Security and Governmental Affairs and the Se-  
12 lect Committee on Intelligence of the Senate and the Com-  
13 mittee on Homeland Security and the Permanent Select  
14 Committee on Intelligence of the House of Representa-  
15 tives.

16       “(b) AUDIT.—The Under Secretary for Intelligence  
17 and Analysis of the Department shall conduct an annual  
18 audit of the information systems and bulk data of the Of-  
19 fice of Intelligence and Analysis, which shall be consistent  
20 with the intelligence oversight guidelines of the Office of  
21 Intelligence and Analysis.

22       “(c) REPORT.—Not later than 30 days after the con-  
23 clusion of the audit under subsection (b), the Under Sec-  
24 retary for Intelligence and Analysis of the Department  
25 shall submit to the appropriate congressional committees  
26 the findings and results of such audit.”.

1       (b) CLERICAL AMENDMENT.—The table of contents  
2 in section 1(b) of the Homeland Security Act of 2002  
3 (Public Law 107–296; 116 Stat. 2135) is amended by in-  
4 serting after the item relating to section 210G the fol-  
5 lowing:

“Sec. 210H. Annual audit of information systems and bulk data.”.
