We are writing to invite you to testify before the Subcommittee on Contracting Oversight at a hearing entitled, "Oversight of Reconstruction Contracts in Afghanistan and the Role of the Special Inspector General." The hearing will be held on Thursday, November 18, 2010 at 2:30 P.M. in Room SD-342 of the Dirksen Senate Office Building. This will allow adequate time for you to engage in questions and answers with members of the Subcommittee.
