Dear Mr. Sims:

We are writing to invite you or your designee to testify before the Subcommittee on the Efficiency and Effectiveness of Federal Programs and the Federal Workforce and the Subcommittee on Financial and Contracting Oversight at a joint hearing entitled, "Safeguarding our Nation's Secrets: Examining The Security Clearance Process." The hearing will be held on Thursday, June 20, 2013 at 2:30 p.m. in Room SD-342 of the Dirksen Senate Office Building.

The purpose of the hearing is to review how the federal government conducts investigations to determine whether federal employees and contractors are eligible for access to classified information. The hearing will examine the management and oversight of the federal employees and contractors responsible for planning, conducting, and reviewing investigations and issuing security clearances. The hearing will also examine the efficiency and effectiveness of the security clearance process.

Your testimony should address the role of Defense Security Services (DSS) in overseeing the access and use of classified information by federal employees and contractors, including policies and procedures for awarding security clearances and conducting oversight of contractor facilities. Your testimony should also include the Defense Department's approximate annual costs for obtaining security clearances for Defense Department military, civilian, and contractor employees. In addition, your testimony should include information regarding DSS' contracts for support services, including the number and duties of contractor employees who provide support to DSS' mission. You should be prepared to answer questions regarding how DSS holds federal employees and contractors accountable for the misuse of classified information.

We request that you summarize your testimony in 5 minutes, although a longer written statement may be submitted for the official record. This will allow adequate time for you to engage in questions and answers with members of the Subcommittee. **Subcommittee rules require that your testimony be submitted by no later than 2:30 P.M. on Tuesday, June 18, 2013.** Please send official correspondence relating to this invitation, including an electronic copy of your written statement and a brief one page biography, to Subcommittee Clerk, Kelsey Stroud, at Kelsey_Stroud@hsgac.senate.gov.

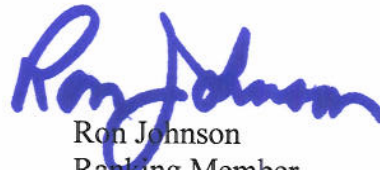
