I understand that you are beginning a review of Rule of Law programs conducted by the State Department, USAID, and the Defense Department in Afghanistan. I am writing to request that you include the State Department's Justice Sector Support Program (JSSP) in your review.

The purpose of the JSSP is to provide assistance to the government of Afghanistan to strengthen the institutional capacity of its criminal justice system. Since April 2005, the State Department has awarded contracts worth over \$187 million to PAE to implement the JSSP. <sup>1</sup>

I first requested information regarding the JSSP in June 2011.<sup>2</sup> In response to my request, the State Department produced approximately 6,800 pages of documents, including the JSSP task order, related contract materials, and evaluations.<sup>3</sup> My request is enclosed for your review.

Based on a review of these documents, I have serious concerns about the effectiveness of the JSSP. The documents provided to the Subcommittee reveal that the Department failed to ensure that there were performance measures for the program before 2009, more than four years after PAE began work. It appears that the contractor, not the Department, was responsible for setting these objectives and there is no indication that the Department provided input or oversight regarding the accuracy or objectivity of the contractor-designed metrics.

I am also concerned that the JSSP and other rule of law programs in Afghanistan may not be improving Afghanistan's legal institutions. In fact, despite the investment of more than \$900 million on rule of law programs in Afghanistan, there is some indication that the situation may actually have worsened. For the past seven years, Foreign Policy and the Fund for Peace have jointly produced an annual index of failed states, ranking nations based on factors including the stability of the government and the rule of law. In 2005, the year that the JSSP began, Afghanistan was ranked 11<sup>th</sup> among the most failed states in the world. In 2012, Afghanistan's rating dropped to the 6<sup>th</sup> most failed state in the world.

The documents and information received by the Subcommittee raise troubling questions about JSSP and the State Department's oversight of the JSSP and similar programs. As a result, I request that you include the JSSP in your ongoing review of rule of law programs. I look forward to reviewing any findings that you release.

The Subcommittee on Contracting Oversight is currently reviewing the award and management of contracts for the Justice Sector Support Program (JSSP) in Afghanistan. The contract was awarded to Pacific Architects and Engineers (PAE), Inc., a former subsidiary of Lockheed Martin now owned by Lindsay Goldberg L.L.C.

To assist the Subcommittee's review of this contract, please provide the following documents and information related to the JSSP contract covering the period from solicitation through October 1, 2010:

- (1) The final contract and all modifications:
- (2) Documents related to the justification of any modification;
- (3) If the contract was a task order off of an established indefinite-delivery, indefinite-quantity contract, the base contract and all modifications;
- (4) The solicitation document and all amendments;
- (5) PAE's final proposal, both technical and cost, which led to the award of the contract to PAE;
- (6) The memoranda which documented the justification for award to PAE, any trade-offs made during the source selection process, the negotiations with PAE, the responsibility determination, and the determination of price reasonableness;
- Analyses, including all required determinations and findings, and communications regarding the exercise of any options;
- (8) Evaluations, including justifications, required under Federal Acquisition Regulation § 42.15 regarding PAE's performance;

- (9) Stop work orders, if issued;
- (10) PAE's invoicing and payment history for the contract and any communications related to available funding for the contract;
- (11) Inspection and acceptance reports and any communications related to inspection and acceptance;
- (12) Plans detailing how PAE's performance would be monitored and communications related to PAE's performance under the contract.

I request that you provide this information as soon as possible, but in no case later than Friday, July 15, 2011. If you determine that you will be unable to make a complete production by this date, please contact Subcommittee staff to discuss possible modifications to this schedule.
