## Dear General Bostick:

On November 19, 2012, Senator Susan Collins and I wrote to you regarding a settlement agreement between the U.S. Army Corps of Engineers (USACE) and the contractor DynCorp International LLC (DynCorp) relating to the construction of a garrison for the Afghan National Army in Kunduz Province, Afghanistan. We raised concerns regarding USACE's decision to pay DynCorp more than \$70 million under contracts worth \$72.8 million. As you know, a report by the Special Inspector General for Afghanistan Reconstruction (SIGAR) found that DynCorp's work on construction of the garrison was so poor that several buildings at the garrison were unsafe, uninhabitable, or unusable.

On December 12, 2012, USACE staff met with Homeland Security and Governmental Affairs Committee staff to provide the briefing requested in our letter. At the meeting, USACE staff stated that USACE intended to conduct a complete review of the terms and circumstances surrounding the settlement agreement with DynCorp. Committee staff requested and USACE staff agreed to provide copies of that review upon completion.

According to *Bloomberg News*, USACE has now completed its internal review and has determined that the settlement was proper and reasonable.<sup>3</sup> To date, the Committee has not
