We are writing to invite you or your designee to testify before the Subcommittee on Financial and Contracting Oversight at a hearing entitled, "Contract Management by the Department of Energy." The hearing will be held on Thursday, June 27, 2013, at 10:30 a.m. in Room SD-342 of the Dirksen Senate Office Building.

The purpose of the hearing is to review contract management by the Department of Energy's Office of Environmental Management. We request that you summarize your testimony in 5 minutes, although a longer written statement may be submitted for the official record. This will allow adequate time for you to engage in questions and answers with members of the Subcommittee. Subcommittee rules require that your testimony be submitted by no later than 2:30 P.M. on Tuesday, June 25, 2013.
