Dear Mr. Miller:

We are writing to invite you to testify before the Subcommittee on the Efficiency and Effectiveness of Federal Programs and the Federal Workforce and the Subcommittee on Financial and Contracting Oversight at a joint hearing entitled, "Safeguarding our Nation's Secrets: Examining The Security Clearance Process." The hearing will be held on Thursday, June 20, 2013 at 2:30 p.m. in Room SD-342 of the Dirksen Senate Office Building.

The purpose of the hearing is to review how the federal government conducts investigations to determine whether federal employees and contractors are eligible for access to classified information. The hearing will examine the management and oversight of the federal employees and contractors responsible for planning, conducting, and reviewing investigations and issuing security clearances. The hearing will also examine the efficiency and effectiveness of the security clearance process.

Your testimony should address the policies and procedures of the Office of Personnel Management's Federal Investigative Services (FIS) for conducting investigations for federal agencies. Your testimony should also address FIS' contracts for investigative and support services, including the type, cost, and number of full-time employees responsible for managing and overseeing each contract. In addition, your testimony should address the costs and prices of conducting investigations. You should be prepared to answer questions regarding how FIS holds federal employees and contractors accountable for incomplete, inaccurate, or fabricated investigations. You should also be prepared to answer questions regarding OPM's role in overseeing federal agencies' use of investigations to award clearances.

We request that you summarize your testimony in 5 minutes, although a longer written statement may be submitted for the official record. This will allow adequate time for you to engage in questions and answers with members of the Subcommittee. **Subcommittee rules require that your testimony be submitted by no later than 2:30 P.M. on Tuesday, June 18, 2013.** Please send official correspondence relating to this invitation, including an electronic copy of your written statement and a brief one page biography, to Subcommittee Clerk, Kelsey Stroud, at Kelsey_Stroud@hsgac.senate.gov.

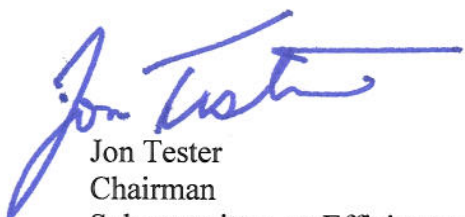
