- (5) Date of award and dates of performance;
- (6) The original value of the contract;
- (7) Amount invoiced or received to date;
- (8) Services being provided to each agency and component covered by the contract;

I request that you provide this information to the Subcommittee as soon as possible, but in no case later than Thursday, **July 25, 2013**.
