Dear Mr. Dodaro:

We are writing to invite you or your designee to testify before the Subcommittee on Financial and Contracting Oversight at a hearing entitled, "Oversight of Small Agencies." The hearing will be held on Thursday, April 10, 2014 at 10:00 A.M. in Room SD-342 of the Dirksen Senate Office Building.

Vigorous oversight by an independent inspector general is one of the federal government's most important tools to prevent and detect waste, fraud, and abuse of taxpayer dollars. The purpose of the hearing is to review the processes and mechanisms by which small agencies and other federal entities without statutory inspectors general receive oversight. The hearing will examine the process by which small agencies contract with independent inspectors general for services. The hearing will also explore the role of the Council of Inspectors General for Integrity and Efficiency (CIGIE) in ensuring that small agencies have adequate oversight. Finally, the hearing will examine potential legislative actions to improve the oversight of small agencies.

Your testimony should discuss the Governmental Accountability Office's prior audits and reviews of small agencies that do not have inspector general oversight. Your testimony should also address the circumstances under which a small agency merits inspector general oversight and the challenges associated with providing that oversight in an efficient and comprehensive manner. Your testimony should also discuss issues associated with designated federal entity and smaller inspector general offices, including budget authority, resources, and independence.

The Subcommittee requests that you summarize your testimony in 5 minutes, although a longer written statement may be submitted for the official record. This will allow adequate time for you to engage in questions and answers with members of the Subcommittee. **Subcommittee rules require that your testimony be submitted by no later than 10:00 A.M. on Tuesday, April 8, 2014.** Please send an electronic copy of your written statement and a brief one page biography to Subcommittee Clerk, Kelsey Stroud, at Kelsey_Stroud@hsgac.senate.gov.

The jurisdiction of the Subcommittee on Contracting Oversight is set forth in Senate Rule XXV clause 1(k); Senate Resolution 445 section 101 (108th Congress); and Senate Resolution 64 (113th Congress).
