Dear Colleagues:

Thank you for your letter dated August 17, 2017. I am in complete agreement with your recognition that "we have an obligation to ensure that the federal government is ready and able to combat and defeat terrorism of all types and keep our country safe." I share your desire to examine ways that we can counter all violent extremists.

Since I became Chairman, this committee has held ten hearings on countering terrorism, both foreign and domestic. Just this June, we held a hearing titled "Ideology and Terror: Understanding the Tools, Tactics, and Techniques of Violent Extremism." The purpose of the hearing was to examine "the root causes of violent extremism."

As you know, when the Senate returns to Washington after the August recess period, our Committee will hold a hearing to examine the most pressing domestic and foreign threats facing the United States. I plan to ask the Acting Secretary of the Department of Homeland Security, the Director of the FBI, and the Director of the
