Dear Secretary Tillerson:

The Committee on Homeland Security and Governmental Affairs is continuing to conduct oversight of the security of visa programs and operations. On or about October 24, 2011, the State Department approved an F-2 nonimmigrant visa application submitted by a Saudi Arabian national, Naif Abdulaziz Alfallaj. On February 6, 2018, the Justice Department indicted Mr. Alfallaj for allegedly procuring this visa based on fraudulent representations. Mr. Alfallaj's admission into the United States had potential consequences to homeland security, as he had allegedly attended an al Qaeda training camp in or around September 2000.

In light of Mr. Alfallaj's alleged visa fraud and the potential consequences for homeland security, I write to respectfully request a staff-level briefing about the Department's administration of nonimmigrant visas and its oversight of these programs. In particular, I ask that the briefing address the following issues:

- 1. Please provide a timeline of Mr. Alfallaj's nonimmigrant visa vetting process.
 - a. Has the Department implemented changes to the vetting process since Mr. Alfallaj's 2011 nonimmigrant visa was granted?
 - b. According to the indictment against Mr. Alfallaj, he allegedly made fraudulent representations on his nonimmigrant visa application.⁴ Please explain how the Department verifies the accuracy of an applicant's answers on a visa application.
- 2. Please explain the resources available to the State Department in verifying an applicant's nonimmigrant visa application.

- a. Does the State Department have access to fingerprint analyses performed by the FBI regarding terrorism materials obtained overseas?⁵
- b. Does the State Department have access to the same databases and information as the Department of Homeland Security for the purpose of vetting visa applicants?
- c. The Transportation Security Administration (TSA) revoked Mr. Alfallaj's pilot license after finding that Mr. Alfallaj posed or was suspected of posing a risk of air terror. Does the State Department have access to the vetting tools that enabled the TSA to suspect that Mr. Alfallaj posed a threat to airline or passenger safety?
- 3. According to an FBI affidavit supporting the Justice Department's complaint, Mr. Alfallaj's wife held an F-1 nonimmigrant visa as of October 2011 and Mr. Alfallaj's father applied for a nonimmigrant visa in 2014. Please explain the visa or immigration status of Mr. Alfallaj's family members in light of his indictment for visa fraud.
- 4. Please provide data on the number of open and pending investigations relating to potential visa fraud or public safety concerns on immigrant and nonimmigrant visa holders in the United States.

Please respond as soon as possible but no later than 5:00 p.m. on March 7, 2018, to arrange the briefing.

The Committee on Homeland Security and Governmental Affairs is authorized by Rule XXV of the Standing Rules of the Senate to investigate "the efficiency, economy, and effectiveness of all agencies and departments of the Government." Additionally, S. Res. 62 (115th Congress) authorizes the Committee to examine "the efficiency and economy of all branches and functions of Government with particular references to the operations and management of Federal regulatory policies and programs."
