3 AND RESETTLEMENT OF EVACUEES FROM
4 AFGHANISTAN.

5 (a) IN GENERAL.—In accordance with the Inspector 6 General Act of 1978 (5 U.S.C. App.), the Inspector Gen-7 eral of the Department of Homeland Security, in coordina-8 tion with any appropriate inspector general, shall conduct 9 a thorough review of efforts to support and process evac-10 uees from Afghanistan. 2

1 (b) ELEMENTS.—The review required by subsection 2 (a) shall include an assessment of the systems, staffing, 3 policies, and programs used— 4 (1) to the screen and vet such evacuees, includ-5 ing— 6 (A) an assessment of whether personnel 7 conducting such screening and vetting were ap-8 propriately authorized and provided with train-9 ing, including training in the detection of fraud-10 ulent personal identification documents; 11 (B) an analysis of the degree to which 12 such screening and vetting deviated from 13 United States law, regulations, policy, and best 14 practices relating to the screening and vetting 15 of refugees and applicants for United States 16 visas that have been in use at any time since 17 January 1, 2016; 18 (C) an identification of any risk to the na-19 tional security of the United States posed by 20 any such deviations; 21 (D) an analysis of the processes used for 22 evacuees traveling without personal identifica-23 tion records, including the creation or provision 24 of any new identification records to such evac-25 uees; and

1	(E) an analysis of the degree to which
2	such screening and vetting process was capable
3	of detecting—
4	(i) instances of human trafficking and
5	domestic abuse;
6	(ii) evacuees who are unaccompanied
7	minors; and
8	(iii) evacuees with a spouse that is a
9	minor;
10	(2) to admit and process such evacuees at
11	United States ports of entry;
12	(3) to temporarily house such evacuees prior to
13	resettlement; and
14	(4) to account for the total number of indi-
15	vidual evacuated from Afghanistan in 2021 with
16	support of the United States Government,
17	disaggregated by—
18	(A) country of origin;
19	(B) age;
20	(C) gender;
21	(D) eligibility for special immigrant visas
22	under the Afghan Allies Protection Act of 2009
23	(8 U.S.C. 1101 note; Public Law 111-8) or
24	section 1059 of the National Defense Author-
25	ization Act for Fiscal Year 2006 (8 U.S.C.

2	evacuation;
3	(E) eligibility for employment-based non-
4	immigrant visas at the time of evacuation; and
5	(F) familial relationship to evacuees who
6	are eligible for visas described in subparagraphs
7	(D) and (E).
8	(c) INTERIM REPORTING.—
9	(1) IN GENERAL.—Not later than 180 days
10	after the date of the enactment of this Act, the In-
11	spector General of the Department of Homeland Se-
12	curity shall submit to the appropriate congressional
13	committees not fewer than one interim report on the
14	review conducted under this section.
15	(2) DEFINITIONS.—In this subsection:
16	(A) APPROPRIATE CONGRESSIONAL COM-
17	MITTEES.—The term "appropriate congres-
18	sional committees" has the meaning given the
19	term in section 12 of the Inspector General Act
20	of 1978 (5 U.S.C. App.);
21	(B) SCREEN; SCREENING.—The terms
22	"screen" and "screening", with respect to an
23	evacuee, mean the process by which a Federal
24	official determines—
25	(i) the identity of the evacuee;

1	(ii) whether the evacuee has a valid
2	identification documentation; and
3	(iii) whether any database of the
4	United States Government contains derog-
5	atory information about the evacuee.
6	(C) VET; VETTING.—The term "vet" and
7	"vetting", with respect to an evacuee, means
8	the process by which a Federal official inter-
9	views the evacuee to determine whether the
10	evacuee is who they purport to be, including
11	whether the evacuee poses a national security
12	risk.
13	(d) DISCHARGE OF RESPONSIBILITIES.—The Inspec-
14	tor General of the Department of Homeland Security shall
15	discharge the responsibilities under this section in a man-
16	ner consistent with the authorities and requirements of the
17	Inspector General Act of 1978 (5 U.S.C. App.) and the
18	authorities and requirements applicable to the Inspector
19	General of the Department of Homeland Security under
20	that Act.
21	(e) COORDINATION.—Appropriate officials of any
22	Federal agency and appropriate inspectors general shall
23	cooperate with the Inspector General of the Department
24	of Homeland Security in the coordination of the require-
25	ments under this section.

1 (f) RULE OF CONSTRUCTION.—Nothing in this sec-2 tion shall be construed to limit the ability of the Inspector General of the Department of Homeland Security to enter 3 4 into agreements to conduct joint audits, inspections, or in-5 vestigations in the exercise of the oversight responsibilities of the Inspector General of the Department of Homeland 6 7 Security, in accordance with the Inspector General Act of 1978 (5 U.S.C. App.), with respect to oversight of the 8 evacuation from Afghanistan, the selection, vetting, and 9 processing of applicants for special immigrant visas and 10 11 asylum, and any resettlement in the United States of such 12 evacuees.
