3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "DHS Joint Task
5	Forces Reauthorization Act of 2022".
6	SEC. 2. AMENDING SECTION 708 OF THE HOMELAND SECU-

19	each Joint Task Force; and
20	"(iv) an assessment of staffing levels
21	and resources of each Joint Task Force.";
