A BILL

To repeal the multi-State plan program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Repeal Insurance
- 5 Plans of the Multi-State Program Act of 2019" or the
- 6 "RIP MSP Act".
- 7 SEC. 2. REPEAL OF MULTI-STATE PLAN PROGRAM.
- 8 (a) Definitions.—In this section, the terms "multi-
- 9 State plan issuer" and "MSP issuer" mean a health insur-
- 10 ance issuer or group of health insurance issuers that has
- 11 a contract with the Office of Personnel Management to

- 4 (b) Program Repeal.—Effective January 1, 2020,
- 5 section 1334 of the Patient Protection and Affordable

- 8 (c) REQUIRED REPORTING.—Not later than 60 days
- 9 after the date of enactment of this Act, the Director of

6	(3) a timeline detailing how OPM will close
7	down the information technology portal that MSP
8	issuers utilize.
9	(d) RESCISSION OF UNUSED FUNDS.—Of the
10	amounts made available to OPM for the purposes of staff-
11	ing and administering the program under section 1334 of
12	the Patient Protection and Affordable Care Act, the unob-
13	ligated balance is rescinded, effective January 1, 2020.
14	(e) Sense of Congress.—It is the sense of Con-
15	gress that—
16	(1) the Director of the Office of Personnel
17	Management should assign employees of the Office
18	whose duties on the date of enactment relate to car-
19	rying out section 1334 of the Patient Protection and
20	Affordable Care Act (Public Law 111–148) to duties
21	relating to processing appeals brought by individuals
22	or employers pursuant to such section 1334; and
23	(2) no additional amounts should be appro-
24	priated for salaries and expenses relating to proc-
25	essing such appeals.
