## AMENDMENT intended to be proposed by Mr. SCOTT of Florida

2 SEC. \_\_\_\_. NO APPROPRIATIONS, NO PAY.

3 (a) DEFINITIONS.—In this section:

4 (1) ESCROW PERIOD.—The term "escrow pe-5 riod" means any period occurring on or after Octo-6 ber 1 of a fiscal year during which both Houses of 7 Congress have not passed all discretionary appro-8 priations measures providing appropriations through 9 the end of that fiscal year (which does not include

1	appropriations under section 1311 of title 31,
2	United States Code, as added by this Act).
3	(2) Member of congress.—The term "Mem-
4	ber of Congress''—
5	(A) has the meaning given under section
6	2106 of title 5, United States Code; and
7	(B) does not include the Vice President.
8	(3) PAYROLL ADMINISTRATOR.—The term
9	"payroll administrator", with respect to a House of
10	Congress, means—
11	(A) in the case of the House of Represent-
12	atives, the Chief Administrative Officer of the
13	House of Representatives, or an employee of
14	the Office of the Chief Administrative Officer
15	who is designated by the Chief Administrative
16	Officer to carry out this section; and
17	(B) in the case of the Senate, the Sec-
18	retary of the Senate, or an employee of the Of-
19	fice of the Secretary of the Senate who is des-
20	ignated by the Secretary to carry out this sec-
21	tion.
22	(b) TIMELY APPROVAL OF APPROPRIATIONS
23	BILLS.—With respect to an escrow period, the payroll ad-
24	ministrator of each House of Congress shall—

(1) deposit in an escrow account all payments
 otherwise required to be made during the escrow pe riod for the compensation of Members of Congress
 who serve in that House of Congress; and

5 (2) release amounts deposited in an escrow ac6 count under paragraph (1) to the applicable Member
7 of Congress at the end of the escrow period.

8 (c) WITHHOLDING AND REMITTANCE OF AMOUNTS 9 FROM PAYMENTS HELD IN ESCROW.—The payroll admin-10 istrator of each House of Congress shall provide for the 11 same withholding and remittance with respect to a pay-12 ment deposited in an escrow account under subsection (b) 13 that would apply to the payment if the payment were not 14 subject to subsection (b).

16 (1) SENATE.—

17 (A) REQUEST FOR CERTIFICATIONS.—On
18 October 1 of each year, the Secretary of the
19 Senate shall submit a request to the Chairman
20 of the Committee on Appropriations of the Sen21 ate for certification of the determinations made
22 under clauses (i) and (ii) of subparagraph (B).

23 (B) DETERMINATIONS.—The Chairman of
24 the Committee on Appropriations of the Senate
25 shall—

1	(i) on October 1 of each year, make a
2	determination of whether an escrow period
3	is in effect and therefore the pay of Sen-
4	ators shall be held in escrow under sub-
5	section (b);
6	(ii) determine the period of days fol-
7	lowing each October 1 that the pay of Sen-
8	ators shall be held in escrow under sub-
9	section (b);
10	(iii) provide timely certification of the
11	determinations under clauses (i) and (ii)
12	upon the request of the Secretary of the
13	Senate; and
14	(iv) submit in writing for the Congres-
15	sional Record the determinations under
16	clauses (i) and (ii).
17	(2) House of representatives.—
18	(A) Request for certifications.—On
19	October 1 of each year, the Chief Administra-
20	tive Officer of the House of Representatives
21	shall submit a request to the Chairman of the
22	Committee on Appropriations of the House of
23	Representatives for certification of the deter-
24	minations made under clauses (i) and (ii) of
25	subparagraph (B).

1	(B) DETERMINATIONS.—The Chairman of
2	the Committee on Appropriations of the House
3	of Representatives shall—
4	(i) on October 1 of each year, make a
5	determination of whether an escrow period
6	is in effect and therefore the pay of Mem-
7	bers of the House of Representatives shall
8	be held in escrow under subsection (b);
9	(ii) determine the period of days fol-
10	lowing each October 1 that the pay of
11	Members of the House of Representatives
12	shall be held in escrow under subsection
13	(b);
14	(iii) provide timely certification of the
15	determinations under clauses (i) and (ii)
16	upon the request of the Chief Administra-
17	tive Officer of the House of Representa-
18	tives; and
19	(iv) submit in writing for the Congres-
20	sional Record the determinations under
21	clauses (i) and (ii).
22	(e) EFFECTIVE DATE.—This section shall take effect
23	on February 1, 2021.
