3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Periodically Listing
5	Updates to Management Act of 2022" or the "PLUM Act
6	of 2022".
7	SEC. 2. ESTABLISHMENT OF PUBLIC WEBSITE ON GOVERN-
8	MENT POLICY AND SUPPORTING POSITIONS.
9	(a) Establishment.—

1	(1) In General.—Subchapter I of chapter 33
2	of title 5, United States Code, is amended by adding
3	at the end the following:
4	"§ 3330f. Government policy and supporting position
5	data
6	"(a) Definitions.—In this section:
7	"(1) Agency.—The term 'agency' means—
8	"(A) any Executive agency, the United
9	States Postal Service, and the Postal Regu-
10	latory Commission;
11	"(B) the Architect of the Capitol, the Gov-
12	ernment Accountability Office, the Government
13	Publishing Office, and the Library of Congress;
14	and
15	"(C) the Executive Office of the President
16	and any component within that Office (includ-
17	ing any successor component), including—
18	"(i) the Council of Economic Advi-
19	sors;
20	"(ii) the Council on Environmental
21	Quality;
22	"(iii) the National Security Council;
23	"(iv) the Office of the Vice President;
24	"(v) the Office of Policy Development;
25	"(vi) the Office of Administration;

1	"(vn) the Office of Management and
2	Budget;
3	"(viii) the Office of the United States
4	Trade Representative;
5	"(ix) the Office of Science and Tech-
6	nology Policy;
7	"(x) the Office of National Drug Con-
8	trol Policy; and
9	"(xi) the White House Office, includ-
10	ing the White House Office of Presidential
11	Personnel.
12	"(2) Appointee.—The term 'appointee'—
13	"(A) means an individual serving in a pol-
14	icy and supporting position; and
15	"(B) includes an individual serving in such
16	a position temporarily in an acting capacity in
17	accordance with—
18	"(i) sections 3345 through 3349d
19	(commonly referred to as the 'Federal Va-
20	cancies Reform Act of 1998');
21	"(ii) any other statutory provision de-
22	scribed in section 3347(a)(1); or
23	"(iii) a Presidential appointment de-
24	scribed in section $3347(a)(2)$ .

1	"(3) COVERED WEBSITE.—The term 'covered
2	website' means the website established and main-
3	tained by the Director under subsection (b).
4	"(4) DIRECTOR.—The term 'Director' means
5	the Director of the Office of Personnel Management.
6	"(5) Policy and supporting position.—The
7	term 'policy and supporting position'—
8	"(A) means any position at an agency, as
9	determined by the Director, that, but for this
10	section and section 2(b)(3) of the PLUM Act of
11	2022, would be included in the publication enti-
12	tled 'United States Government Policy and
13	Supporting Positions' (commonly referred to as
14	the 'Plum Book'); and
15	"(B) may include—
16	"(i) a position on any level of the Ex-
17	ecutive Schedule under subchapter II of
18	chapter 53, or another position with an
19	equivalent rate of pay;
20	"(ii) a general position (as defined in
21	section 3132(a)(9)) in the Senior Execu-
22	tive service;
23	"(iii) a position in the Senior Foreign
24	Service;

1	"(iv) a position of a confidential or
2	policy-determining character under sched-
3	ule C of subpart C of part 213 of title 5,
4	Code of Federal Regulations, or any suc-
5	cessor regulation; and
6	"(v) any other position classified at or
7	above level GS–14 of the General Schedule
8	(or equivalent) that is excepted from the
9	competitive service by law because of the
10	confidential or policy-determining nature of
11	the position duties.
12	"(b) Establishment of Website.—Not later than
13	1 year after the date of enactment of the PLUM Act of
14	2022, the Director shall establish, and thereafter the Di-
15	rector shall maintain, a public website containing the fol-
16	lowing information for the President in office on the date
17	of establishment and for each subsequent President:
18	"(1) Each policy and supporting position in the
19	Federal Government, including any such position
20	that is vacant.
21	"(2) The name of each individual who—
22	"(A) is serving in a position described in
23	paragraph (1); or

1	"(B) previously served in a position de-
2	scribed in such paragraph under the applicable
3	President.
4	"(3) Information on—
5	"(A) any Government-wide or agency-wide
6	limitation on the total number of positions in
7	the Senior Executive Service under section
8	3133 or 3134 or the total number of positions
9	under schedule C of subpart C of part 213 or
10	title 5, Code of Federal Regulations; and
11	"(B) the total number of individuals occu-
12	pying such positions.
13	"(c) Contents.—With respect to any policy and
14	supporting position listed on the covered website, the Di-
15	rector shall include—
16	"(1) the agency, and agency component, (in-
17	cluding the agency and bureau code used by the Of
18	fice of Management and Budget) in which the posi-
19	tion is located;
20	"(2) the name of the position;
21	"(3) the name of the individual occupying the
22	position (if any);
23	"(4) the geographic location of the position, in
24	cluding the city, State or province, and country;

1	"(5) the pay system under which the position is
2	paid;
3	"(6) the level, grade, or rate of pay;
4	"(7) the term or duration of the appointment
5	(if any);
6	"(8) the expiration date, in the case of a time-
7	limited appointment;
8	"(9) a unique identifier for each appointee;
9	"(10) whether the position is vacant; and
10	"(11) for any position that is vacant—
11	"(A) for a position for which appointment
12	is required to be made by the President, by and
13	with the advice and consent of the Senate, the
14	name of the acting official; and
15	"(B) for other positions, the name of the
16	official performing the duties of the vacant po-
17	sition.
18	"(d) Current Data.—For each agency, the Direc-
19	tor shall indicate in the information on the covered website
20	the date that the agency last updated the data.
21	"(e) FORMAT.—The Director shall make the data on
22	the covered website available to the public at no cost over
23	the internet in a searchable, sortable, downloadable, and
24	machine-readable format so that the data qualifies as an

1	open Government data asset, as defined in section 3502
2	of title 44.
3	"(f) Authority of Director.—
4	"(1) Information required.—Each agency
5	shall provide to the Director any information that
6	the Director determines necessary to establish and
7	maintain the covered website, including the informa-
8	tion uploaded under paragraph (4).
9	"(2) Requirements for agencies.—Not
10	later than 1 year after the date of enactment of the
11	PLUM Act of 2022, the Director shall issue instruc-
12	tions to agencies with specific requirements for the
13	provision or uploading of information required under
14	paragraph (1), including—
15	"(A) specific data standards that an agen-
16	cy shall follow to ensure that the information is
17	complete, accurate, and reliable;
18	"(B) data quality assurance methods; and
19	"(C) the timeframe during which an agen-
20	cy shall provide or upload the information, in-
21	cluding the timeframe described under para-
22	graph (4).
23	"(3) Public accountability.—The Director
24	shall identify on the covered website any agency that
25	has failed to provide—

1	"(A) the information required by the Di-
2	rector;
3	"(B) complete, accurate, and reliable infor-
4	mation; or
5	"(C) the information during the timeframe
6	specified by the Director.
7	"(4) Annual updates.—
8	"(A) IN GENERAL.—Not later than 90
9	days after the date on which the covered
10	website is established, and not less than once
11	during each year thereafter, the head of each
12	agency shall upload to the covered website up-
13	dated information (if any) on—
14	"(i) the policy and supporting posi-
15	tions in the agency;
16	"(ii) the appointees occupying such
17	positions in the agency; and
18	"(iii) the former appointees who
19	served in such positions in the agency
20	under the President then in office.
21	"(B) Supplement not supplant.—In-
22	formation provided under subparagraph (A)
23	shall supplement, not supplant, previously pro-
24	vided information under that subparagraph.

"(5) OPM HELP DESK.—The Director shall es-1 2 tablish a central help desk, to be operated by not 3 more than 1 full-time employee, to assist any agency 4 with implementing this section. 5 "(6) COORDINATION.—The Director may des-6 ignate 1 or more agencies to participate in the devel-7 opment, establishment, operation, and support of the 8 covered website. With respect to any such designa-9 tion, the Director may specify the scope of the re-10 sponsibilities of the agency so designated. 11 "(7) Data standards and timing.—The Di-12 rector shall make available on the covered website 13 information regarding data collection standards, 14 quality assurance methods, and time frames for re-15 porting data to the Director. "(8) REGULATIONS.—The Director may pre-16 17 scribe regulations necessary for the administration 18 of this section. 19 "(g) Responsibility of Agencies.— 20 "(1) Provision of information.—Each agen-21 cy shall comply with the instructions and guidance 22 issued by the Director to carry out this section, and, 23 upon request of the Director, shall provide appro-24 priate assistance to the Director to ensure the suc-25 cessful operation of the covered website in the man-

1	ner and within the timeframe specified by the Direc-
2	tor under subsection $(f)(2)$ .
3	"(2) Ensuring completeness, accuracy
4	AND RELIABILITY.—With respect to any submission
5	of information described in paragraph (1), the head
6	of an agency shall include—
7	"(A) an explanation of how the agency en-
8	sured the information is complete, accurate
9	and reliable; and
10	"(B) a certification that the information is
11	complete, accurate, and reliable.
12	"(h) Information Verification.—
13	"(1) Confirmation.—
14	"(A) IN GENERAL.—On the date that is 90
15	days after the date on which the covered
16	website is established, the Director, in coordina-
17	tion with the White House Office of Presi-
18	dential Personnel, shall confirm that the infor-
19	mation on the covered website is complete, ac-
20	curate, reliable, and up-to-date.
21	"(B) CERTIFICATION.—On the date on
22	which the Director makes a confirmation under
23	subparagraph (A), the Director shall publish on
24	the covered website a certification that the con-
25	firmation has been made.

1	"(2) Authority of director.—In carrying
2	out paragraph (1), the Director may—
3	"(A) request additional information from
4	an agency; and
5	"(B) use any additional information pro-
6	vided to the Director or the White House Office
7	of Presidential Personnel for the purposes of
8	verification.
9	"(3) Public comment.—The Director shall es-
10	tablish a process under which members of the public
11	may provide feedback regarding the accuracy of the
12	information on the covered website.
13	"(i) Data Archiving.—
14	"(1) In general.—As soon as practicable
15	after a transitional inauguration day (as defined in
16	section 3349a), the Director, in consultation with
17	the Archivist of the United States, shall archive the
18	data that was compiled on the covered website for
19	the preceding presidential administration.
20	"(2) Public availability.—The Director
21	shall make the data described in paragraph (1) pub-
22	licly available over the internet—
23	"(A) on, or through a link on, the covered
24	website;
25	"(B) at no cost; and

1	"(C) in a searchable, sortable,
2	downloadable, and machine-readable format.".
3	(2) CLERICAL AMENDMENT.—The table of sec-
4	tions for subchapter I of chapter 33 of title 5,
5	United States Code, is amended by adding at the
6	end the following:
	"3330f. Government policy and supporting position data.".
7	(b) Other Matters.—
8	(1) Definitions.—In this subsection, the
9	terms "agency", "covered website", "Director", and
10	"policy and supporting position" have the meanings
11	given those terms in section 3330f of title 5, United
12	States Code, as added by subsection (a).
13	(2) GAO REVIEW AND REPORT.—Not later than
14	1 year after the date on which the Director estab-
15	lishes the covered website, the Comptroller General
16	of the United States shall conduct a review of, and
17	issue a briefing or report on, the implementation of
18	this Act and the amendments made by this Act,
19	which shall include—
20	(A) the quality of data required to be col-
21	lected and whether the data is complete, accu-
22	rate, timely, and reliable;
23	(B) any challenges experienced by agencies
24	in implementing this Act and the amendments
25	made by this Act; and

1	(C) any suggestions or modifications to en-
2	hance compliance with this Act and the amend-
3	ments made by this Act, including best prac-
4	tices for agencies to follow.
5	(3) Sunset of Plum Book.—Beginning on
6	January 1, 2026—
7	(A) the covered website shall serve as the
8	public directory for policy and supporting posi-
9	tions in the Government; and
10	(B) the publication entitled "United States
11	Government Policy and Supporting Positions",
12	commonly referred to as the "Plum Book",
13	shall no longer be issued or published.
14	(4) Funding.—
15	(A) In general.—No additional amounts
16	are authorized to be appropriated to carry out
17	this Act or the amendments made by this Act.
18	(B) Other funding.—The Director shall
19	carry out this Act and the amendments made
20	by this Act using amounts otherwise available
21	to the Director.
