- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Securing Healthcare
- 5 and Response Equipment Act of 2020" or the "SHARE
- 6 Act of 2020".

3	(a) AMENDMENT.—Title V of the Homeland Security
4	Act of 2002 (6 U.S.C. 311) is amended by adding at the
5	end the following:
6	"SEC. 529. TRANSFER OF EQUIPMENT DURING A PUBLIC
7	HEALTH EMERGENCY.
8	"(a) Authorization of Transfer of Equip-
9	MENT.—During a public health emergency declared by the
10	Secretary of Health and Human Services under section
11	319(a) of the Public Health Service Act (42 U.S.C.
12	247d(a)), the Secretary, at the request of the Secretary
13	of Health and Human Services, may transfer to the De-
14	partment of Health and Human Services, on a reimburs-
15	able basis, personal protection equipment or medically nec-
16	essary equipment in the possession of the Department.
17	"(b) Determination by Secretaries.—
18	"(1) In general.—In carrying out this sec-
19	tion—
20	"(A) before requesting a transfer under
21	subsection (a), the Secretary of Health and
22	Human Services shall determine whether the
23	personal protection equipment or medically nec-
24	essary equipment is otherwise available, includ-
25	ing available by required performance of a con-

1	tract or order under section 101 of the Defense
2	Production Act of 1950 (50 U.S.C. 4511); and
3	"(B) the Secretary shall determine whether
4	the personal protection equipment or medically
5	necessary equipment requested to be trans-
6	ferred under subsection (a) is excess equipment.
7	"(2) NOTIFICATION.—The Secretary of Health
8	and Human Services and the Secretary shall each
9	submit to Congress a notification explaining the de-
10	termination made under subparagraphs (A) and (B),
11	respectively, of paragraph (1).
12	"(c) REQUIRED INVENTORY.—The Secretary shall—
13	"(1) maintain an inventory of all personal pro-
14	tection equipment and medically necessary equip-
15	ment in the possession of the Department; and
16	"(2) make the inventory required under para-
17	graph (1) available, on a continual basis, to—
18	"(A) the Secretary of Health and Human
19	Services; and
20	"(B) the Committee on Appropriations and
21	the Committee on Homeland Security and Gov-
22	ernmental Affairs of the Senate and the Com-
23	mittee on Appropriations and the Committee on
24	Homeland Security of the House of Representa-
25	tives "
