A BILL

To manage supply chain risk through counterintelligence training, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Supply Chain Security

5 Training Act of 2021".

6 SEC. 2. TRAINING PROGRAM TO MANAGE SUPPLY CHAIN
7 RISK.

8 (a) IN GENERAL.—Not later than 180 days after the
9 date of the enactment of this Act, the Administrator of
10 General Services, through the Federal Acquisition Insti-

tute, shall develop a training program for officials with
 supply chain risk management responsibilities at executive
 agencies.

4 (b) CONTENT.—The training program shall be de-5 signed to prepare such personnel to perform supply chain 6 risk management activities and identify and mitigate sup-7 ply chain security threats that arise throughout the acqui-8 sition lifecycle, including for the acquisition of information 9 and communications technology. The training program 10 shall—

(1) include, considering the protection of classified and other sensitive information, information on
current, specific supply chain security threats; and

14 (2) be updated as determined to be necessary15 by the Administrator.

16 (c) COORDINATION AND CONSULTATION.—In devel-17 oping the training program, the Administrator shall—

(1) coordinate with the Federal Acquisition Security Council, the Secretary of Homeland Security,
and the Director of the Office of Personnel Management; and

(2) consult with the Director of the Department
of Defense's Defense Acquisition University and the
Director of National Intelligence.

(d) GUIDANCE.—Not later than 180 days after the
 training program is developed under subsection (a), the
 Director of the Office of Management and Budget shall
 promulgate guidance to Federal agencies requiring execu tive agency adoption and use of the training program.
 Such guidance shall—

7 (1) allow executive agencies to incorporate the
8 training program into existing agency training pro9 grams; and

10 (2) provide guidance on how to identify execu11 tive agency officials with supply chain risk manage12 ment responsibilities.

13 SEC. 3. REPORTS ON IMPLEMENTATION OF PROGRAM.

14 Not later than 180 days after the completion of the 15 first course, and annually thereafter for the next three 16 years, the Administrator of General Services shall submit 17 to the appropriate congressional committees and leader-18 ship a report on implementation of the training program 19 required under section 2.

20 SEC. 4. DEFINITIONS.

21 In this Act:

(1) APPROPRIATE CONGRESSIONAL COMMITTEES AND LEADERSHIP.—The term "appropriate
congressional committees" means—

1	(A) the Committee on Homeland Security
2	and Governmental Affairs and the Committee
3	on Armed Services of the Senate; and
4	(B) the Committee on Oversight and Re-
5	form and the Committee on Armed Services of
6	the House of Representatives.
7	(2) INFORMATION AND COMMUNICATIONS
8	TECHNOLOGY.—The term "information and commu-
9	nications technology" has the meaning given the
10	term in section 4713(k) of title 41, United States
11	Code.
12	(3) EXECUTIVE AGENCY.—The term "executive
13	agency" has the meaning given the term in section
14	133 of title 41, United States Code.
15	(4) TRAINING PROGRAM.—The term "training
16	program" means the training program developed
17	pursuant to section 2(a).
